


and another \$738 for Samaritan's Purse – funds that will go toward Ukraine relief.

My Experience With Getting C7 Engine Misfire Fixed

I am writing this story in hopes that none of the other C7 owners in our club or any friends of theirs had the same misfire problems that I had with my 2016. And, be warned, that if the same kind of misfire problem occurs with you or your friends C7, get on record with GM and your warranty company immediately and you MAY get assistance from them.

I had three torque converter and transmission problems with my 2016 when it was young, that eventually were corrected. Then, I had the following occur. In August of 2020, when my car was still covered by the 5 year Power Train Warranty, a misfire developed in #2 cylinder. The car shuttered and felt very similar to the torque converter/transmission issue so I had it flat-bedded to Bob Steele Chevrolet Service Department. At that point, there was only 19,696 miles on the car. The dealer contacted me a few days later and told me #2 fuel injector and spark plug were replaced and it was done under a warranty Repair Order. It ran fine until April of 2021, another 976 miles, when it started to misfire again so I took it back to the dealer. This time the problem was diagnosed as being in #8 cylinder and the dealer told me they replaced the spark plug and wire to correct the misfire. Here's the 'good' part — it was not covered by the Power Train Warranty because it had expired in December 2020. I objected and told the dealer I had been discussing the problem with other car guys and also had looked on internet sites, which outlined similar problems and the source of this problem was deeper than spark plugs and wires. The dealer Service Manager said there was no bulletin on this problem but it was repaired, however, my Power Train Warranty had expired and I had to pay \$269.76 to get my car back.



Then in November 2021 after putting on 650 additional miles, another misfire developed. Since Bob Steele Chevrolet didn't fix the problem during the first two tries I had the car flat-bedded to Boniface-Hires Chevrolet Service Department. After several days the service writer contacted me and said, 1. I didn't drive the car enough, and 2. They needed to replace all of the spark plugs and wires that would cost me \$ 912 plus tax. I told him not to do anything and called Bob Steinmetz, *The Vette Doctor*. Bob told me he was familiar with C7 problems and to bring it in and he'd check it out.

I drove the car, misfiring, to *The Vette Doctor* on December 7, 2021 where it had been until March 2 when I picked it up after a new crate motor was installed. Fortunately, due to the extended warranty I purchased when I bought the car, I only had to pay the \$100 deductible to the insurance company.

I am so thankful that I took the car to *The Vette Doctor*, because Mr. Steinmetz handled all of the submissions and contact with my extended warranty company. More importantly, Bob investigated until he found the real cause of the spark plugs fouling, which was oil blow-by due to a broken piston ring. The oil migrated through the engine fouling other spark plugs and causing the motor to be replaced.



My Adrenaline Rush: Ron Fellows Performance Driving School

Driving a Corvette on the street is a blast but doing it safely is another thing. The way to safely drive the car to its potential is either in an Autocross, Track or Drag Strip environment. As the owner of a new Corvette, GM offers the opportunity to experience all these elements of performance driving at the Spring Mountain Motorsports facility in Pahrump, Nevada at a substantial discount.

The experience begins at the welcome center and gift shop located outside the gated facility where you are given identification wrist bands and the keys to your

condominium. Breakfast and lunch are provided in the clubhouse each day. The first day of instruction begins in the class room where you are fitted with a helmet and HANS device, which you will wear throughout the course when driving.

The two day course is set up in one hour sessions, four sessions in the morning and four in the afternoon. There was a classroom session and then you proceed to your assigned car for a driving session. The elements you will experience include wet surface ABS braking control exercises; autocross practice the first day; competition the second day; track time with the instructor leading and the student following; instructor demo laps with the instructor driving your car and you are the passenger; serpentine and other car control exercises; Performance Data Recorder use; and review with your instructor.

Becky was able to sit in on all the classes and then would head out to a tower to observe and take pictures of our time on the track and the autocross sessions. She took a Demo ride with an instructor on the track in my assigned car and got the ride of a lifetime with speeds up to 117 mph.

The Ron Fellows Driving School was one of the most exciting things that I have ever done. It was two days of pure adrenaline rush. The only other time I had such an experience was at

the NCM track in Bowling Green when I took a ride with a professional driver. Corvettes are made to run.

National Council of Corvette Clubs Report

My report is not going to be your common report on NCCC events and Florida region events. However, I will mention that competition season in Florida has ended. Convention in June is coming soon. CKCC has been given the honor of hosting the Florida Region Corvette Clubs Annual Awards Picnic. This is a social event, an event to meet your corvette family from far and wide. I just received an email from Fred Dugach and Donna Huddle who have started a new club called Corvettes in Paradise, located in Naples. They are coming to the picnic. Roni and I met them at convention in Cleveland and instantly felt like we had known them for years. Tom Henry is also coming to the picnic with two "old members". Tom is a past president of NCCC and a charter member of NCCC. If your new to CKCC this is your chance to belong to something great. Ok, getting on with the information you may know, but if your new.....

The governor has many duties, the issue of liability insurance, provided by NCCC is one I take very seriously. I have recently reviewed the Wavier signed sheets for the car show as required. Most participants signed, however 22 of our own did not. I went back through the forms, spending Wednesday, Thursday and Friday evening trying to decipher the handwriting. I emailed our secretary who help with insurance and NCCC rules.

Liability insurance is provided to all NCCC members regardless of signing the waiver or not. Liability insurance has many variables. Under certain situations the signing of a wavier is required. CKCC has a rule that requires all participants including spectators,

vendors and anyone at the event to sign the waiver. NCCC does have a requirement, which you may not know.

The recent car show was a NCCC sanctioned peoples 'choice concours. This means it is a competition held under the NCCC Competition Rule Book. One section reads as follows.

1.6. REPORTING EVENT RESULTS 1. The results of an event MUST be entered into the NCCC Competition Database System. (01/15) 2. If an entrant did not sign the waiver, all entrants in that person's class will move up in placement as if that person had not entered. That person will be placed in the last position in their class with 0 points and "no waiver" placed in the remark's column. 3. Official results are to include only NCCC entrants and workers. However, an overall result sheet of both NCCC and non-NCCC entrants may be included if the Host Club so desires.

The Governor is required to report event results. The car show is a single event. Participates who showed their car (drivers) get 3 points added to the database. Workers get 2 points added to the database. Those who did not sign the wavier will not receive any points, as per NCCC rules.

As your governor I am requesting that you take this issue of signing the wavier seriously. I am asking all CKCC members to print your name legibly and sign the wavier.

I would like to encourage everyone to visit the NCCC website; corvettesnccc.org and tap on the insurance box. Then go to FAQ section.

Our March Autocross

On March 19 & 20, CKCC hosted the inaugural NCCC-sanctioned events of the 2022 Competition Season at the American Muscle Car Museum. Twenty two NCCC drivers from the Florida region (17 from CKCC), three from the Southeast region and two from the MidWest region competed under blue skies and balmy Florida temperatures. On Saturday, we had two open class drivers Julie Wilson in a Porsche and Les Pritchard in a Corvette. He has recently become a member of CKCC and will be part of the 1SN class at future events. On Sunday there were four metal cars competing (and helping defray the cost of the venue).

With the addition to the Maintenance building nearing completion, and

construction materials no longer being stored close to the roadway behind it; we were once again able to set a course using the "full track". Seven events were held each day, with drivers able to make two attempts (runs) for each event. On Saturday, I had the Ladies Fastest Time of the Day at 45.979 seconds and Men's FTD went to Jason Brzozowski at 44.191 seconds. On Sunday, I had the Ladies



FTD at 47.011 seconds and Men's FTD went to Jason Brzozowski at 44.244 Seconds. Back when CKCC held autocrosses at the BCC/EFSC Palm Bay campus, the club bought hamburgers for all workers; and there were enough fast food choices nearby, so drivers were on their own for lunch. Since moving to



The American Muscle Car Museum, we have a departure time we've needed to honor and taking 1+ hours for lunch would have made that impossible so the club began ordering cheap pizza for the drivers and workers to keep everyone on site for a short lunch break. For this weekend's events, Vivi Iduate set up food trucks for both days; which was a welcome relief from the pizza we had been serving. The club no longer has to bear that expense; and the attendees really enjoyed Bill's Grills and the Hot Dog food trucks. Bill's Grill was so good, some of us chipped in for a whole beef brisket for a tailgating that evening at a local hotel.





other clubs north of us to catch up. At this time, CKCC is the #1 club with 3,902 points, the closest second is CowTown Vettes in Texas with 3,078 points. CKCC Top 10 Nationally ranked drivers are Zachary Duys (10), Veronica Duys (1), Connie Koystra (3), Sharon Bridge (4) and Lloyce Campbell (5).

CKCC drivers assisted as corner workers throughout the day. We are also lucky to have a few very dedicated workers we know we can count on for every autocross. Thanks to



all the workers who make these events possible. Phil Strode is the worker coordinator and runs the worker meeting; Dick Merrill helps tech cars and works a corner station; Charlie Acton works in the timing tent; Lynn Kassebaum and Patsy Shearer help with Registration and waivers; and the following were corner workers — Lesley Goodbread, Jerry Pownall, David Glenn and Cindy Barrett. And the biggest thank you to Judi Thompson who somehow manages to fit 120 cubic feet of stuff in a 72 cubic foot trailer.
